

Introduction

The Hospital Authority (HA) is a statutory body responsible for managing all public hospitals and related services in Hong Kong. We have a workforce of about 76,000 for managing over 28,300 beds in total, 43 hospitals and institutions, 48 Specialist Out-patient Clinics (SOPCs), and 73 General Out-patient Clinics (GOPCs).
